WATSON HARROP – was question by stewards to his involvement in the incident which saw David Lowther unseat from I predict a riot in the first run of the race after the stewards looked at the video evidence which showed Mr Harrop cause interference with Rhyds Cocoa and Ric Park which put the 9-year-old gelding off stride and to hook up

with I Predict a Riot which caused the unseating of the driver. Mr Harrop was found guilty of rule M17, finned £100, given 3 demerit points and the horse Eternal Luck was

disqualified

Ric Park — was questioned by the stewards about interference in the re-run caused to Greentree Ruby (Ryan Inglis) who hooked up with wellfield roco then had to be pulled up. Mr Park explained that he felt his horse followed Eternal luck over to the pylons when it had crossed over as his horse had been interfered with on the first run of the race that he felt his horse was trying to avoid any further interference. They stewards discussed and felt that there was sufficient clearance for Mr Harrop to clear and that it didn't have any impact on Rhyds Cocoa causing the interference to Greentree Ruby. Mr Park was found guilty of M17 fined £100 given 3 demerit points and Rhyds Cocoa was disqualified.

ALEXIS Laidler was questioned by the stewards after a complaint was made about her horse had left the track to change/alter harness between the first run and the rerun, Mrs Laidler explained that the horse Greenhill Lou Lou had left the track with permission of the paddock steward and that the reason to-do so was to pump up a tyre that her husband Rocker Laidler who was driving thought it was a little soft and that they put some air in the tyre, the stewards were happy that they were no rules broken and the all clear was given
